The North Shore Horse and Pony Association was formed in 1975 to ensure that horses and horseriding activities continue to form a vital part of the community and lifestyle in Terrey Hills/Duffys Forest and in Ku-ring-gai and Garigal National Parks.

Please become a member and join us in our efforts.

In October 2009 Warringah Council prepared a new Discussion Paper *Horse riding trails and facilities in Terrey Hills & Duffys Forest October 2009* and sought community comment on the paper. NSHPA submitted a detailed response, including the preliminary findings of a NSHPA survey of equestrian activity in Terrey Hills, Duffys Forest and Ingleside which so far has surveyed 78 properties, encompassing 570 riders and 447 horses.

This is the synopsis of our response:

- Vote of thanks to Warringah Council
- The use of community horse riding facilities and the commercial impact of the recreational rider in Terrey Hills and Duffys Forest is seriously underestimated.
- The Bridle Trail is a valuable community asset. It requires ongoing maintenance and greater attention to safety.
- Council's recognition of the current maintenance and safety issues for the Bridle Trail is welcomed. NSHPA notes this is applicable to all horse riding routes, including designated trails, and recommends appropriate standards.
- There are an insufficient number of authorised horse trails in Terrey Hills, Duffys Forest and Ingleside.
- A Multiple-Use Trail Network authorised for horse riding is required.
- NSHPA does not support re-routing of the Bridle Trail.
- NSHPA recommends the formalisation of all links with appropriate signage as recommended in the *Warringah Regional Multiple-Use Trail Strategy*.
- NSHPA encourages the development and maintenance of public horse riding arenas as per its previous consultations with Council representatives.
- NSHPA as a representative community group is willing to be included in any future user group discussions.

In particular we noted that horse activities are the commercial life blood of Terrey Hills and Duffys Forest

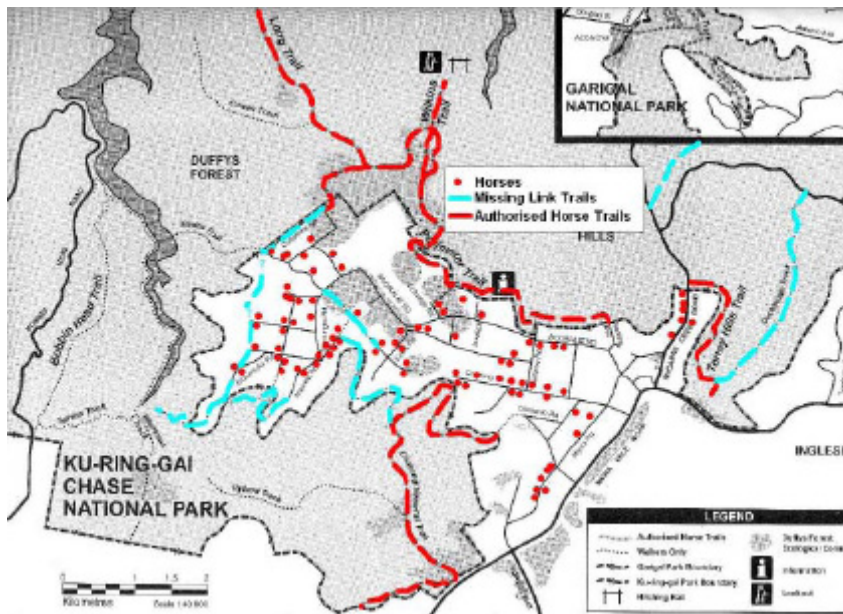

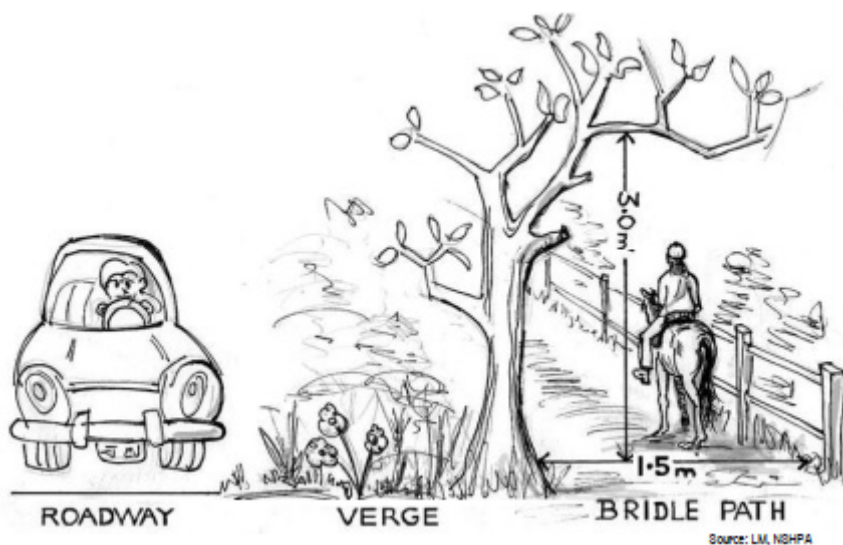
and that the location of the trails, including the Bridle Trail along Booralie and Thuddungra Rds, is insufficient to provide a safe recreational experience for the number and location of horses and riders in the area. NSHPA proposed a multiple-use trail network be authorised. This would provide a safe strategic network of horse riding routes to serve recreational horse riders throughout the area and would address many of the community's safety concerns, especially for child riders. The proposed network is shown in the map below:

(Please note that the Centre Track is only partially shown, and that the Chiltern Track is located off the map to the right.)

In our submission NSHPA also recommended that an appropriate base line standard for horse trails is at least 1.5m wide and 3 m high.



These are just some of the points NSHPA raised in our submission! We are pleased to have had the full support of other local horse groups such as Forest Hills Pony Club and Ingleside Riders Group Inc.. ## ANEMBO ARENA

The Duffy Forest Residents Association (DFRA) was successful in receiving a \$30,000 Community Building Partnership Grant to upgrade the Anembo Public Horse Arena, known as Anembo Reserve.

We would like to thank and congratulate the DFRA, and especially Jenny Harris, for researching and collating all the detailed information required to submit such a comprehensive grant application. The huge effort Jenny put in on behalf of all the users of the arena is much appreciated. Thanks must also go to the NSW state government for its initiative in providing such grants for deserving local community projects.

NSHPA, DFRA, Northside Riding Club and Forest Hills Pony Club have pledged monies to boost the \$30,000 grant by around \$15,000. Warringah Council also pledged a contribution, in the form of labour, to alter fencing, create a new entrance as well as providing machinery to complete the project. We are enormously grateful for the support Warringah Council has pledged to work with DFRA in this upgrade and restoration.

If we need to raise more money we hope we can have the continuing support of our friends and members when we hold fund raising events. Anembo arena is 2.5 sizes bigger than a normal arena so as you can imagine these \$'s will not go far.

A working Committee of interested local riders and local residents, representatives from Northside Riding Club, NSH&P, Forest Hills Pony Club and DFRA are meeting every month, and sometimes fortnightly, to ensure that we get the most satisfactory outcome for the local community.

We are very mindful of the inconvenience this work will cause horseriders when the works are being done. We hope riders will all be understanding while the restoration works are being undertaken.

For your information, the project description is included below:

- The public arena was built in the early 1970s by local community members through their Rotary membership. It was surfaced with rubber chips but these have washed off the arena, degrading an area of adjacent bushland. The surface is now degraded such that it has become difficult for horses and riders to use parts of the arena.
- Restoration would include preparation of a new base, rectification of current levels and improved drainage with suitable sand top-up.
- Warringah Council have agreed to relocate the arena's opening to minimize impact on adjacent bushland.
- Placement of telegraph poles along east west boundary to prevent runoff of surface into bushland.
- The restoration will return the arena to a condition which will allow the continued use of this activity.
